## FACCOMBE CROSS COUNTRY RIDE 2019

*Sunday 23<sup>rd</sup> June 2019*

The Course will be open from 10 a.m. to 1.00 p.m.

The course covers approximately 10 miles over one of Hampshire's most stunning areas of countryside and outstanding natural beauty. There is an optional shorter route. Every line of jumps and road crossings will be stewarded. A rosette will be presented to every rider and a photographer will be on the course.

### **DIRECTIONS - Post Code SP11 ODS**

The ride will start and finish adjacent to the Jack Russell Inn, Faccombe, directions for parking will be well signed.

**From the A34:** take the A343 towards Andover, at Hurstbourne Tarrant take the first right to Netherton (opposite the garage complex) to Netherton. After approximately a mile turn right to Faccombe and then follow the signs.

**From Andover:** take the A343 towards Newbury, go through Enham Alamein, at Hurstbourne Tarrant take the left to Netherton (opposite the garage complex). After approximately a mile turn right to Faccombe and then follow the signs.

## **RULES**

1. Hard hats which meet the current BS standards and body protectors are strongly recommended. Appropriate cross country dress to be worn.
2. Horses and ponies must be at least four years old.
3. Children under twelve must be escorted by an adult.
4. Riders must not deviate from the course under any circumstances.
5. Any rider riding in a dangerous or reckless manner will be sent home.
6. No entries will be refunded without a medical or vet's certificate.
7. In the event of cancellation, the entry fee will be refunded less £3 per entry for administration costs.
8. The decision of the organizers on any matter shall be final.
9. Dogs to be kept on a lead at all times.
10. No horse/pony may be ridden round the course more than once.
11. Please ensure that you finish the course by 3:00 pm when the stewards will be stood down.

Every effort should be made to give way to faster riders and likewise, faster riders must respect slower riders and make every effort to avoid upsetting slower horses when they pass.
